Mandatory requirements must be obtained before the commencement of the course.

* Tourism additional charges will be in accordance with travel/excursions undertaken & uniform requirement. Teacher will notify of costs. At least 6 weeks' notice will be provided prior to the event. Payment will be required prior to departure.

** Our VET programs work closely with industry and therefore it is a **compulsory** part of the course to wear a uniform for work placement and excursion purposes. VET subject charge is payable once only.

EDUCATION ACT:

The Education Act, effective from 20 January 2020, requires young people to stay in education and training until they:

- complete Year 12
- are enrolled in, to complete a Certificate III (not including ASbA)
- turn 18
- have an apprenticeship

The Education Act increases education and training leaving requirements and sets additional requirements for education training providers, young people, and parents and guardians to ensure that young people are supported in planning and staying engaged with post-Year 10 education and training.

An exemption may be granted if they gain full-time employment of at least 35 hours a week. Students will remain as an active enrolment until such time this evidence is supplied. De-enrolment cannot occur until this requirement is fulfilled.

REFUND POLICY:

Student enrolment withdrawal from Rosny College prior to 31 May 2023 may receive a pro-rata refund or credit on the General levy.
