Rosny College Levies 2020

General, Additional and VET Levies invoices will be posted out late in February and payment is due by end of March 2020.

STAS Students: Students who are approved for STAS but have received a levy invoice need to provide their STAS number to the Office (phone 6244 9200) to have their invoice cancelled.

GENERAL SUBJECT LEVIES:

Enrolments before I July:

l subject = 150 hours - \$105.00	2 subjects = 300 hours - \$210.00
3 subjects = 450 hours - \$315.00	4 subjects = 600 hours - \$420.00

Enrolments after I July: \$50.00 per subject to a maximum of \$210.00

If 600 hours (4 subjects) or more, the student is considered to be a full time student with a levy of \$420.00.

ADDITIONAL COSTS:

Subject area

As well as a general levy, some subject attract additional charges for compulsory uniforms and/or partial recovery of expensive resources utilised in that subject area.

REFUND POLICY:

Note - A Leaver's Form must be completed to obtain a refund.

When a student withdraws from Rosny College, the following refunds will apply:

Prior to 31 March	100% less administration fee of \$20
Prior to 29 April	75% less administration fee of \$20
Prior to 29 May	50% less administration fee of \$20
Prior to 3 July	25% less administration fee of \$20

Nil refunds for Levies apply after 3 July 2020

Nil refunds are paid for students who pay **2020 Other Fees** for subjects, as these funds are used to establish classes and to purchase additional resources for the relevant learning programs.

Unpaid Levies & Other Fees for Students who WITHDRAW from the College With the exception of STAS approved students, pro rata Levies and Other Fees will be payable for any student who withdraws from the College.
